Shall the Board of Education of the Van-Far R-I School District, Missouri, be authorized to increase the operating tax levy ceiling to \$3.9608 per one hundred dollars of assessed valuation for the purpose of providing additional funds to better maintain its facilities, retain qualified staff and meet other operating needs of the District?

If this proposition is approved, the adjusted operating levy of the School District is estimated to increase by \$0.58 from \$3.3808, currently, to \$3.9608 per one hundred dollars of assessed valuation for the 2018 Tax Year and will be applied to the assessed valuation for each year thereafter.
