Hancock County General Primary Election

(Carthage, Illinois) -Voters in Montebello Precinct Number 4 in Hancock County will decide whether to continue the prohibition of the sale at retail of alcoholic liquor on March 20, 2018.

Voters in Montebello Precinct Number 4 who do not wish to vote in a party primary may request a nonpartisan ballot. Voters should carefully read the public question - since the wording may be confusing. The wording is the format required by state law. The referendum requires a simple majority to be approved.

Polls open at 6:00 A.M. and close at 7:00 P.M. statewide in Illinois. Results of close contests may not be known until April 10, 2018 since absentee ballots may "float-in" through the mail until that date according to state law.

General Primary Election Press Advisory

The telephone number for returns on Election Night is 217-357-3911. You are welcome to have a reporter at the County Clerk's Office, Second Floor, Courthouse, Carthage, Illinois on Election Night.

If you want someone to telephone you with final returns please telephone me before election night. Then we will telephone you with final results after the ballot counting is finished.

If you desire precinct by precinct returns either have a representative here to pick up a canvass, or one may be mailed to you after the election.

The first precinct is expected to be counted by 8:00 P.M. on Election Night. The last precinct is expected to be counted by 10:20 P.M. on Election Night.

Important items about the General Primary Election include:

1. Polls open at 6:00 A.M. and close at 7:00 P.M. statewide in Illinois.
2. A list of polling places is included in this Press Advisory. Hancock County has thirty-three (33) precincts.
3. A list of all candidates and referenda is included in this Press Advisory.
4. Hancock County is expected to have approximately 12,600 registered voters on Election Day.
5. Results of any close contests may not be know until April 10, 2018 because absentee ballots may "float in" for three weeks after the election, according to Illinois law.
